Privacy Notice

Introduction

Under the GDPR, there are six data protection principles that Carney Consultancy Ltd must comply with. These provide that the personal information we hold about you must be:

Data Security

The information we collect

The information we collect will depend entirely on our relationship with you as a client/supplier. We do not pass information to third parties in order to protect your confidentiality unless you have given consent for us to do so.

If you are a customer or supplier

If you are a customer or supplier the information we will collect will be that which we require to process the relevant information within the confines of our contract.

We collect name and contact details, payment details where appropriate and in addition, we ask you to supply information about the type of person or organisation you are so we understand your relationship with Carney Consultancy Ltd so as to tailor future communications to you.

We hold this information on paper securely in our office and/or on our secure server and/or within our accounting software as an account record for you. This information includes;

- Company Name
- Company Address
- Company registration information
- VAT number/status
- Company Buyer / Sales / Accounts / Key employee contact information
- Telephone / Fax numbers
- Email address
- Details of orders placed with you
- Suppliers' relevant bank details in order to process online payments
- Details of payments made
- Details of transactions queried and the outcome
- Trading reference requests
- Details of your products or services

Further information which may be retained as part of our contract may include the following;

- Accident Records
- Accident Investigations
- Witness Statements
- Training Records
- National Insurance Identification
- Peoples Date of Births

Access to your information (Your Rights)

You have the right to ask for a copy of the personal information Carney Consultancy Ltd holds about you and to correct any inaccuracies in that information.

- Right to fair processing of information and transparency over how we use your personal information we are required to inform you why we want to gather your personal information, what we will do with it, who it will be shared with and how long it will be kept for. That information is set out in this privacy notice, but if you require any further information please don't hesitate to contact us.
- Right to request a copy of your information you can request a copy of your information which we hold (this is known as a 'subject access request'). If you would like a copy of some or all of this information please contact us with proof of your identity and let us know what information you would like. We must provide this information to you in a commonly used and machine readable format.
- **Right to require us to correct any mistakes in your information** you can require us to correct any information which we hold. If you would like to do this, please contact us to let us know the information that is incorrect and what is should be replaced with.
